#### Treasurer's report 2022

The account books for the Parish have been examined and approved by our Independent Examiner Mr John Jackson who also produced the 2022 Financial Statement.

Janet Bell and I continue to work together organising the weekly banking for both churches in the Parish and Janet does the gift aid claim for the Parish.

We have ended the year excess receipts over payments of  $\pounds$ 978 more income than outgoing. This is largely due to the fact that we received a legacy of  $\pounds$ 5000 to be used for the fabric of the church and some generous donations from members of the parish.

Voluntary giving from the Parish Giving Scheme has increased slightly and other envelope giving has increased by £1350.

Certain items have been restricted which includes the energy grant received from the diocese of £2096.

The parish giving scheme continues to work well, it helps knowing how much is being paid into our account each month.

We would appreciate it if anyone who gives regularly would consider joining the Parish Giving Scheme or setting up a direct debit/standing order.

# The Vicars Reflections on 2022

The APCM is a time to look back and reflect on the year, giving thanks to God for all that has happened. It's also a time to look to the future and what we would like to see happening in the coming year. 2022 was the year when things returned to 'normal', except that things should never be 'normal' with God and so it has proved. Exciting new things have happened in both 2022 and early in 2023 which can be traced back to our PCC away day in the summer of 2022, when we reviewed our Mission Action Plan and made a commitment to become more outward focused.

This was the stimulus for the work to create the community choir, for the Easter holiday club and for the Eco-fair and the Lego events that Helen has organised (with others) so brilliantly.

In addition to these new initiatives, Messy Church – which had to be mothballed after just two meetings when covid arrived – was firmly re-established in 2022 and continues to attract families and children to have fun and hear the gospel message briefly in an informal manner. If you add to this the events that involve contact with the community which have been faithfully led by members of the congregation for many years – Noah's Ark, Open the Book, the youth group and Bethany – then it is clear that we have found many ways to reach people who are not regularly part of church. Of course, what we want most of all is for people to give their lives to Jesus, but this can never happen unless we first make contact with them.

We all only have so much time and energy to give to these new activities, so it is right that we constantly keep the things we do under review and decide when they are no longer needed. The numbers at the evening services had been in decline for some time, with most of those who came along also having worshipped in the morning. We had already reduced the number of evening services to two per month – the Book of Common Prayer (BCP) service and the contemporary service – but numbers continued to decline at the BCP even when the time was changed to 4 p.m. during the winter. We therefore decided to end the BCP services and instead to hold a Family Communion on the second Sunday morning of each month so that Communion was still celebrated.

It is sad to see people no longer being able to come along to services and Christmas was another time when many people were poorly; we were reminded again of the sadness of failing health and the essential role of people in the congregation who visit those in ill health. But there has also been joy as we have seen a number of new people come into both St Michael's and St Mary's and become regular worshippers.

Before Christmas there was, of course, Advent and the great response to the Paddington course, with its focus on invitation. Although I would love to have more prayer and Bible study going on in the church, I am encouraged by the response to Advent and Lent courses and to the group who are faithfully meeting for prayer and study on a Thursday morning.

Of course, there are many roles that are not so visible in the church, but which are essential to its running: I am hugely grateful to the wardens for all that they do, Roz for her crucial work in the area of safeguarding, those who lead junior church, make tea and coffee, clean the church and do all sorts of other unseen tasks. I make no apology for having devoted most of this report to reaching out to the community, because this is essential if the church is to remain alive. However, people will only want to be part of the church if they see a loving group of people, who are willing to do some distinctly unglamorous jobs in order to keep everything running smoothly.

At no time was this more evident than after the death of the Queen, when people volunteered at very short notice to do all sorts of tasks. I hope Ann-Marie won't feel embarrassed when I mention that it was the welcome that she received when she came into church after the Queen's death that encouraged her to come back on a Sunday; she and Joanne have since become regular members of the congregation. These are the types of things that happen when we are the sort of people that Paul urges us to be in Romans 15:5-7:

May the God who gives endurance and encouragement give you the same attitude of mind toward each other that Christ Jesus had, so that with one mind and one voice you may glorify the God

#### Independent Examiner's report to the P.C.C. of Newburn Parish

#### PCC Away Day report

The PCC had an Away Day held at Shepherd's Dene on 13th August 2022.

Roz led a review of our Safeguarding Policy, which meant that all PCC members were brought up to date on what training was needed and what she has to do behind the scenes to keep us running smoothly.

Allison then gave everyone a piece of 'seed paper'. Each sheet included 100's of wild flower seeds and can be planted once written on/finished with. The paper represents us sowing seeds within God's Kingdom. We all wrote a prayer/poem/thought, or drew a picture to represent ourselves on the paper, whilst enjoying the grounds of Shepherd's Dene.

Without naming names, some people drew a tree, a reflection of drought and the hot weather, and the worry of the big trees at St Mary's. Others used trees to represent growth of the church, of the youth group, of Noah's Ark. Someone wrote a prayer about seeds growing in the dark but blossoming in the light. Others drew the flowers which might grow from the seed paper to show that you never know exactly what growth will happen from us planting seeds. Another wrote a prayer of growth and said they would plant the seeds in a pot to distinguish them from any weeds that might grow.

We used the 2019 Mission Action Plan to review what has/ has not been achieved. We discussed the need to share out the person with oversight so that it is not always Allison. We need to work together as a whole church not just a PCC, and focus on the church in our community. We wrote new action points for a new MAP, with a big focus on outreach and community.

## **Church Wardens' Report**

The last year felt more 'normal' with not only services but many other Parish activities returning such as Noah's Ark, Messy Church and Bethany. The Archdeacon's Visitation took place on Thursday 16 June 2022 at Holy Cross Church Fenham. It was good to be 'sworn in' at a church in the Newcastle West Deanery.

**St Mary's** average attendance is 35 adults and occasionally up to 4 children.

The new boiler was installed in January 2022; despite a few teething troubles early on all seems to be running smoothly. In June 2022, the boiler house flooded but even with the attendance of three church wardens, an emergency plumber was contacted who fixed the problem free of charge. A Good Samaritan!

The church grounds are maintained by Jim Armstrong and Ken Ladzrie. We are grateful for their help. Following the Quinquennial Inspection Report, the 'Good Shepherd' stained glass window was repaired along with some smaller panes.

At St Michael's, the average attendance is 19 on a Sunday morning. The usual annual inspections and services took place.

The reordering of the church was completed after the removal of pews and re-siting of two radiators. The North aisle now has a pleasant area for coffee after services. It provides a good place to sit and chat.

The children's area in the South Transept is also complete with a table, chairs, carpet and toys.

During the year we have had issues with masonry wasps; hopefully the coolness of the church will encourage them to vacate during the winter.

The front area of the church is greatly improved thanks to the grass being regularly cut during the year by Newcastle City Council workers.

We must also the mention the hard work of Jim Armstrong, Ken Ladzrie and Kevin who are also maintaining the church grounds. A review of safes in both churches resulted in numerous registers being deposited at Woodhorn Records Office.

## **Deanery Synod Report**

The meetings of Newcastle West Deanery are now chaired by Rev James McGowan, our new Area Dean working in partnership with Allison.

As things increasingly open up following Covid, the subject of finance has continued to come up as some parishes were unable to continue with their usual payment of parish share as when the churches were closed income had dropped considerably. This was something that was not such an issue in Newburn Parish as we are much involved in the Parish Giving Scheme. Now Churches are being asked to consider how they might move forward and regroup. It seems that vacancies in parishes will increase in length. The Deanery Development Group will hopefully have more influence in how clergy are deployed across the parishes. At one meeting a presentation was given by Diocesan Generous Giving Team. They reiterated that parish giving had fallen across the diocese and shared various ways to encourage generous giving. Digital Giving Rollout - a national initiative - was shared. Fenham and Ponteland both find it successful, particularly at weddings, but Denton had not gained any benefit. 30 free devices are available for interested parishes. Various factors will be taken into consideration when allocating the devices. Those in church each week will see that Newburn has a device, which is productive at weddings and funerals when people arrive without cash in their pocket!

The deanery has also looked at welcome and hospitality at an open Deanery Synod. Whilst officially we can't say joint Area Deans (!) meetings are much more alive under the leadership of Revd James McGowan and Revd Allison. Deanery Synod will only meet 3 times a year from now on, in line with school terms. A new Deanery Secretary was appointed during the year.

I will shortly stand down from the role of Newcastle West Deanery Synod rep for Newburn - if you'd like to give it a go, do dip your toe in the water - you might just be surprised!

## Messy Church

Messy Church has continued throughout 2022 with a high number of returning families and some new ones still appearing. The word is spreading through Facebook and word of mouth and more families are being attracted to Messy Church. Donations are low but the volunteers are all very generous with their time and resources. We hope we will continue to attract these children for crafts, games, food and as always, a link to a Biblical story or theme. Safeguarding continues to be a central to all we do in Newburn Parish. This year Safeguarding has been on the agenda and discussed at every PCC meeting.

All members of the PCC completed the Domestic abuse training, this training was also open for any member of the congregation to attend. The aim of the training was to develop a greater understanding of what Domestic Abuse is, who it affects, as well as its impact on individuals, children, the wider family, and the community. Those who completed the course demonstrated that they were able to: Identify the different types of domestic abuse, and how wide-spread it is; Recognise the signs of domestic abuse; Explore some of the myths, barriers, stereotypes, and impacts of domestic abuse (in particular how these relate to Christian faith and Church communities); Evaluate the needs of domestic abuse survivors in order to support them effectively, while at the same time understanding the boundaries and limitations of your own role. It also covered a review of the previous safeguarding training (delivered last year). This training was well received, and the participants had a good understanding of the material covered. We have continued to update and review the Parish Dashboard which is an online tool to make it easier for churches to manage their safeguarding requirements. The action plan has been shared and discussed at PCC meetings enabling our safeguarding discussions to have a clear focus.

All safeguarding documents and risks assessments for activities within the parish continue to be updated and reviewed to reflect any changes as needed. The Parish website complies with all safeguarding requirements. Safeguarding information on the notice boards in both churches and the Parish Hall is currently up to date and continues to be updated as needed.

Any safeguarding incidents have been dealt with appropriately, relevant support and guidance has been given where needed and information has been shared with the DSA.
